Submitting Distributor Fuel Tax Returns via CVO Upload Using XML Format

The Vermont Department of Motor Vehicles Commercial Vehicles Operations (CVO) unit, through the CVO Online website will accept XML files for uploading and submitting the following returns:

- Distributor Fuel Tax Return (CVO-102)

XML provides a basic syntax that the CVO uses to share information between different kinds of computers, applications, and organizations without needing to pass through many layers of conversion. Participants must have a working knowledge of XML and XML Schemas. The CVO is unable to provide technical assistance in the development or maintenance of software or web applications owned or operated by applicants and participants.

To file your return, please visit CVO Online at https://cvo.mydmv.vermont.gov/_/ and logon. If you have not created a username, you must create one first in order to submit returns on CVO Online. The applicable XML template is available for download when you log in to file your return online.

The upload process will validate the data in the XML schema is in the correct format. If an error is encountered, it will be displayed for review. In order to resolve any errors, you must fix in the XML schema and upload again. After you upload a valid file, CVO online allows a preview of selected columns from the uploaded schedules. After previewing the schedules, you can verify the totals for inventories, receipts and disbursements by fuel type as well as the tax computation. Once reviewed and confirmed, you can complete the filing of your return by submitting.

Please note: The XML schema is read by an automated process that expects a pre-defined XML format. Please do not make any changes to the XML schema or the upload process will fail. In addition, please ensure that your XML file is formatted with each element on its own line. This facilitates error identification in case there are issues identified during validation.

XML Transmission Fields Description

There are many elements in the schema that are not used by CVO. The table below shows a description of each field that is used by CVO. Fields in the schema that do not appear in the tables below should not be included in the Taxpayer's XML submissions.
